The Alcuin Club was founded by four prominent Anglican laymen in 1897. Since then it has played a significant part in the liturgical renewal of the church and has a long and respected tradition of promoting sound liturgical scholarship by publishing a series of Collections, Tracts and other scholarly works.

The Club played an important part in the debate in the Church of England in the early part of the last century about the proposed revision to the Book of Common Prayer and in other developments. More recently, its aims have been broadened to include study of the liturgy and worship of the Christian churches in general, but with special reference to the lituraical life of the Analican Communion.

The Club is a registered charity managed by a Committee of Trustees made up of both lay and clerical members. The Chairman is the Revd Dr Donald Gray CBE, Canon Emeritus of Westminster and a former President of Societas Liturgica. The other members of the Committee are the Venerable Timothy R Barker, Mr John Collins CBE (Treasurer) Mr David Hebblethwaite OBE, the Revd Canon Christopher P Irvine, the Revd Dr. Gordon P Jeanes (Secretary), The Revd Dr. Simon Jones, the Revd Dr. Ben Gordon-Taylor (Editorial Secretary) Dr Juliette Day and Dr Bridget Nichols.

Membership is open to any individual, institution or library paying the Club's annual subscription. There are currently some 510 members worldwide. Members of the Club are invited to the AGM and occasional lectures. Payment of the annual subscription entitles members to receive free copies of all publications during that particular calendar year. The Club operates a 'Sales and Wants' service exclusively for members who are either selling or seeking out of print Alcuin publications. From time to time the Club also arranges special introductory discounts with other publishers. Members are entitled to buy back stock titles [still in print] at specially reduced rates

The Club also encourages and supports postgraduate research by young liturgical scholars by granting bursaries through the generosity of the Cuming Fund established in memory of the late Dr Geoffrey Cuming. The Alcuin Club is a sponsor of

PRAXIS, a Church of England initiative in pastoral liturgy.
